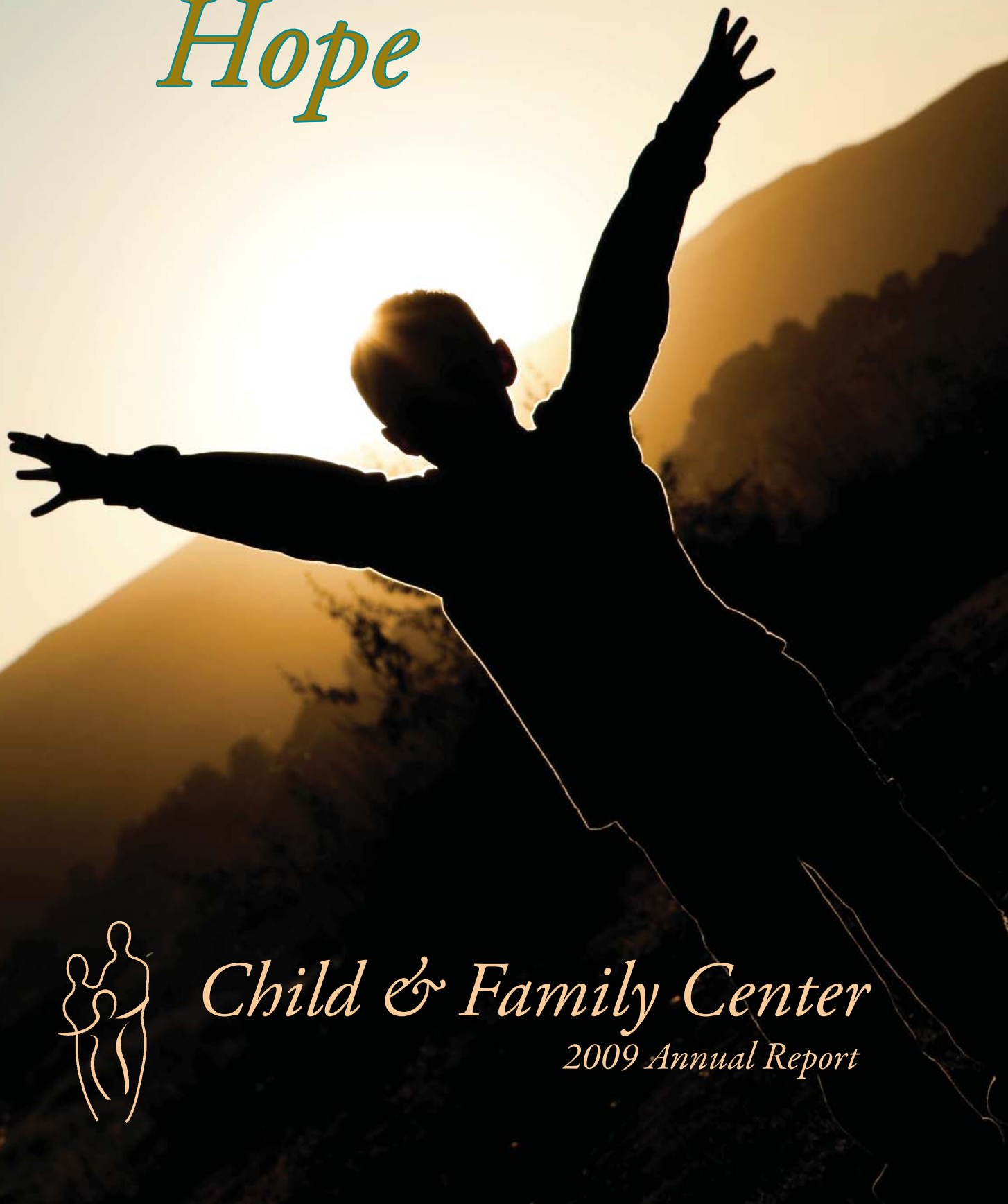

In the midst of economic troubles and emotional turbulence, the Child & Family Center was a beacon of hope for many Santa Clarita Valley families during the last fiscal year.

This hope is best expressed through five new services launched in 2008-2009: the Cal Works Domestic Violence Program, Field Capable Clinical Services, Up Front Assessment Services, Multidiscipline Assessment Services and Wrap Around Tier II Services. Most of these new programs are comprehensive in nature and take place in the homes of the clients.

Although there were cuts to some programs because of state and county financial woes, for the most part the extremely versatile professional staff at the Center has been able to make the adjustments necessary to ensure continuing services to the majority of clients. In some instances there has even been some budgetary enhancement as outlined above with the new mandated programs.

Through all of the difficult uncertainty, the Center Board of Directors has shown fiscal responsibility and care for budget matters that ultimately affect hundreds of lives. These inspirational leaders are the embodiment of selfless volunteerism on behalf of the most fragile children and families in our local neighborhoods, and the Child & Family Center owes them a debt of gratitude.
