Privacy Policy

This policy tells you about Child & Family Center's privacy practices. It applies only to our website www.childfamilycenter.org. It does not apply to information Child & Family Center collects other ways.

It tells you how we collect, use, and disclosure your "personally identifiable" information when you use our website. It also tells you the choices you have about your information.

Child & Family Center honors the privacy of visitors to our website. We will not sell or give away your personally identifiable information without your written consent.

Information collected

We collect information from you when you subscribe to our email lists. We collect it when you respond to a survey or fill out a form. We collect it when you browse our site. If you give us your email address, we may contact you to give you helpful information.

How we use your information

We may use any of the information we collect from you in one or more of these ways:

- to improve our website
- to improve how our website serves you
- to send information of interest to you

How we get information from you

- We collect information you willingly give us through forms, e-mail, and other features.
- We may gather anonymous "traffic data." Traffic data does not personally identify you.
- We use technology (cookies) to collect information about how our site is used. We use cookies mostly
 to get data about site traffic and site interaction through Google Business and Google Analytics. Here

 They are designed to hold a modest amount of data specific to a particular user and website and can
 be accessed either by the web server or the user computer.
- You may opt out of this data collection by turning off cookies and not filling out forms or requests for information.

We do not sell, trade, or give outside parties your personally identifiable information. We may give some non-personally identifiable information to trusted third parties. They help us operate our website, conduct our business, or serve you.

We may release your information when we think it is necessary to comply with the law. We may release it to carry out our site policies or protect rights or safety.
