Our work is grounded in the belief that everyone deserves to live in safety and dignity, and that healing is possible when compassionate, high-quality services are available close to home.



DV Walk for Domestic Violence Awareness – October 10, 2026

The 5K Walk for Domestic Violence Awareness is one of Child & Family Center's most meaningful community events. Each October, individuals, families, businesses, schools, and community leaders come together to raise awareness, honor survivors, remember those affected by abuse, and support the lifesaving services provided through the Center's Domestic Violence Program and Shelter.

This event is not only about walking. It is about standing together as a community and sending a clear message that domestic violence has no place in our homes or neighborhoods. It is about showing survivors that they are seen, believed, and supported.

Funds raised through the Walk help sustain free domestic violence services for survivors and their children, including:

- 24-hour emergency shelter
- 24-hour hotline
- Counseling and therapeutic support
- Legal advocacy
- Restraining order assistance
- Safety planning
- Housing and employment support
- Connections to critical community resources

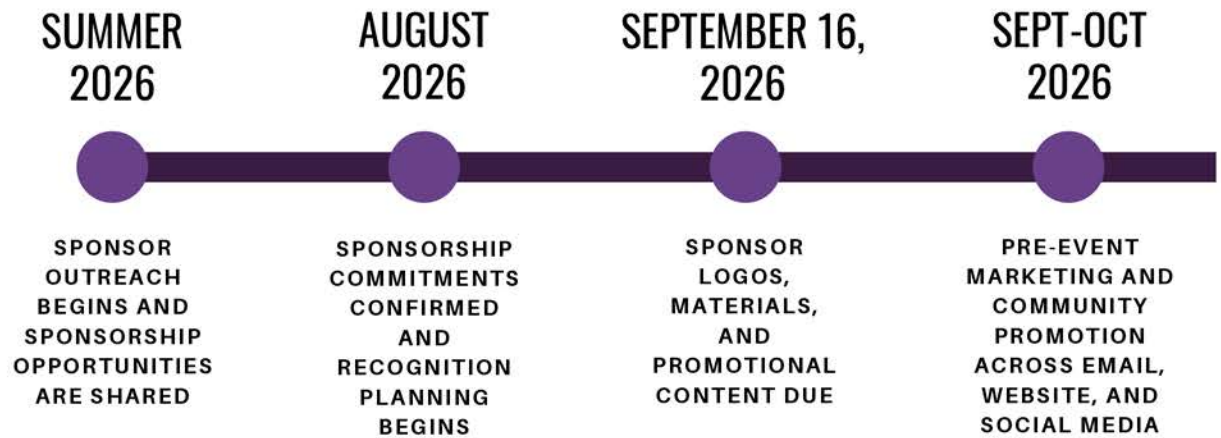
